

“Back to School with Big Boy” Coloring Contest

Official Rules

1. Contest of Skill. THIS IS A CONTEST OF SKILL. WINNERS WILL BE SELECTED ON AN OBJECTIVE BASIS UNDER THE CRITERIA SET FORTH BELOW.
2. Eligibility. NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED. Contest is open only to legal residents of the United States who are ages 12 and under. VOID WHERE PROHIBITED BY LAW OR OTHERWISE RESTRICTED. Employees of Big Boy Restaurants, LLC, its parent and affiliated companies, advertising and promotion agencies, Beaches Resorts, Just 4 Fun Corp., and entities involved in the design and operation of the contest and the immediate family (spouse and parents, siblings, children and their spouses) and members of the immediate household of such individuals are not eligible.
