

AQUAMAN SOCIAL MEDIA CONTEST
Official Rules

1. Contest of participation by Social Media Entrants.
2. Eligibility. NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED. Contest is open only to legal residents of the United States who are ages 18 years and over.
